SUPPLEMENTARY REGULATIONS AND ENTRY FORM

ANNOUNCEMENT:

The Braintree Motorcycle Club will organize a National Sporting Trial to be held under the National Sporting Code of the ACU , the 2010 Standing Trials Regulations, the following Supplementary Regulations and any Final Instructions that may be issued.

ELIGIBILITY: All riders must hold a current ACU registration card or Scottish ACU **license**

EVENT DATE: 11th & 12th September 2010 (Sunday)

START TIME: 09:00am Scrutineering; 07:30am

START LOCATION: Tumblers Green, Stisted, Essex CM77 8AZ

On the road between Stisted Village and Greenstead Green Village.

CLERK OF THE COURSE: Chris Cook LICENCE No TBC

ACU PERMIT No. **TBC**

THE COURSE: A single lap of approximately 90 miles, using public roads, private tracks, Byways and BOAT'S around the County of Essex. There will be a number of observed sections marked on punch cards and according to the ACU standing regulations TSR22 (non-stop) i.e. 0,1,2,3,5 and a timed special test used only as a tie-break.

The special test will be of the form: Start at Line A, stop astride line B.

Should a competitor lose his/her punch card, they should either continue with the trial to the end or sign off as normal, or if retiring from the event inform an official at the earliest possible opportunity. Loss of punch card will mean exclusion from the results.

Route directions will be by way of a road book and supplemented with Day-Glo arrows where necessary.

ALL COMPETITORS MUST SIGN OFF AT FINISH

IMPORTANT.

The course will use public roads; it is the competitor's responsibility to ensure that their machine conforms to all relevant road traffic regulations and laws and is fully insured for the purpose of the trial. The competitor **MUST** give way to horses and walkers. Travelling Marshall's will exclude on the spot any rider behaving in a dangerous or irresponsible manner.
